Sir,

This has reference to NBA's letter of even number dated 28-03-2018 under which **Post Graduate Diploma in Management** program offered by your Institution was granted accreditation for Academic Years 2018-19 to 2020-21 by National Board of Accreditation.

2. The National Board of Accreditation (NBA) has decided that in all cases of Management programs which were accredited for Academic Years 2018-19 to 2020-21 i.e. upto 30-06-2021 in which the Institutions concerned have not been able to apply afresh for accreditation of the programs or if applied, the accreditation process could not be completed due to the current situation arising out of the second wave of the pandemic caused by the Corona virus, the programs would be considered for accreditation of one year after expiry of the validity of accreditation on 30-06-2021 on the basis of the programs meeting the pre-qualifiers. The data submitted by **Jaipuria Institute of Management, Dakachaya Indore dewas Highway, Near Shipra Naka Indore-453771, Madhya Pradesh** in the Pre-qualifiers has been examined and verified in NBA. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the program as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The program has been granted extension of duration of accreditation for one year. **Jaipuria Institute of Management, Dakachaya Indore dewas Highway, Near Shipra Naka Indore-453771, Madhya Pradesh** is requested to apply afresh for accreditation of the program. The application may be submitted online on e-NBA portal by 31st December, 2021.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Jaipuria Institute of Management, Dakachaya Indore dewas Highway, Near Shipra Naka Indore-453771, Madhya Pradesh** as a whole. As such the Institution should nowhere along with its name, including on its letter head etc. write that it is accredited by NBA because NBA only accredits program(s), and not Institutions.
