

Addendum to the Research Policy 2021-22

The management went through an elaborate exercise in discussion with Deans (R), Directors and other eminent researchers and academic administrators to improve our Research Policy to ensure optimum benefit for the institution in various ranking and accreditations.

The Ranking and Accreditations agencies give higher weightage to Management Journals of Scopus (1701 in number as of Nov 2021), WoS Business Collection (207 as of Nov 2021) and FT-50 only and exclude many non-management journals for the purpose of Business Schools.

The addendum emphasizes on the importance of these journals. As per revised policy mentioned below, the research publications accepted till 31st December 2021 will only be monetarily incentivised under old policy which is in force from July 2021. Research papers accepted after 1st January 2022 will be governed and incentivised under the revised research policy.

For the purpose of comprehension and clarity we are attaching the following lists (Excel Sheets), though we are aware that the journal-indexing is dynamic, hence, the researchers are requested to verify the list before every manuscript submission.

- a) List of Scopus Indexed Management Journals
- b) List of WoS Business Collection Journals (The list is called ***Current Contents Business Collection***)
- c) Complete List of ABDC Journals (as of Nov 2021)
- d) ABDC Journals marked in Scopus Management Journals
- e) ABDC Journals marked in WoS Business Collection

Brief Notes:

- a) All Journals which are not in Scopus Management List (1701 in numbers) and WoS (Business Collection, 207 in numbers) shall not be paid monetary incentive if accepted after 31st December 2021. The CAS points will continue for this academic year for these journals.
- b) We have increased the monetary incentive for papers in Scopus management and WoS Business Collection. This is applicable for all the papers published after 1st January 2022.
- c) ***Even A* journals are only recognised if they are indexed in Scopus Management or WoS – BC.*** But looking in to the lead time required for publishing these papers we have still proposed A* without Scopus Management or WOS-BC with half the monetary incentive for this academic year unless the paper is already accepted for publication before 31st December 2021.

*Apart from the number of papers published in Scopus listed journals, citation of research papers of Jaipuria faculty shall also be incentivised. The faculty who cites the research papers of Jaipuria Faculty shall get an additional of .25 CAS points for every two citations.
