This has reference to Appeal dated 13-11-2019 filed by **Jaipuria Institute of Management, 1, Bambala Institutional Area, Pratap Nagar, Sanganer, Jaipur- 302033, Rajasthan** against the decision of NBA granting accreditation to Post Graduate Diploma in Management program of your Institution for 3 years instead of 6 years, communicated vide NBA's letter of even number dated 14-10-2019.

2. The appeal has been considered in NBA. The representatives of your Institution have also presented the case before the Appellate Committee meeting held on 23-12-2019. The Appellate Committee has observed that based on documentary evidence regarding publication in ABDC about 15 publications. As per the expert's opinion, marks are upgraded to 675 taking into all criteria and publication in reputed journals. After careful consideration, the appeal has not been accepted by the Competent Authority. **Therefore, the appeal stands disposed off.**
