The two days FDP on Case teaching and Case Writing intends to hone up the participants' skills in case study method both for the classroom teaching as well as for publications in leading academic Journals and consultancy. The programme will be interactive in nature and will involve group work, interactive lectures, discussions, presentations to offer background, theoretical aspects, as well as practical approaches.
